REPLACEMENT OF EXISTING RESIDENTIAL SIDEWALKS**

Dear Property Owner:

This is to acknowledge your request for information concerning the City's **Residential Sidewalk Participation Program**. This program shares in the cost of replacement of sidewalks, curbs, and the sidewalk portion of a driveway. Only areas within residentially zoned areas will be considered and it does not share in any portion of a driveway approach between the curb and sidewalk or accommodation walks which connect the public sidewalk to the street. The city will reimburse property owners (typically 80%) based on the low bid and is **subject to prior approval of application**. The City's share is based on the unit prices within the low bid. However, if you prefer to choose a contractor with a higher bid, you will be responsible for paying the difference. To improve access to the limited funds available, the maximum participation by the City for any one residence is \$1,000 and a homeowner may submit a maximum of two properties.

**TO APPLY: Submit a completed Sidewalk Participation using the following guidelines:**

*A minimum of two bids, from contractors currently listed by the City Clerk as approved for sidewalk construction in the City of Chillicothe, must accompany the completed application.*

*Each bid must include the same lineal foot or square foot quantities. Differences will slow the approval process.*

*Applications will be accepted through **September 15<sup>th</sup>** of this year, or until allocated funds have been exhausted.*

The City will notify you if your application is approved or disapproved. Approval is valid for the current calendar year only. All sidewalks approved must be completed and reimbursement made on or before December 1, of the year the application was approved.

**FOR REIMBURSEMENT:**

*When work is completed, you pay the contractor the full amount for his services.*

*Forward the paid receipt to City of Chillicothe - City Hall. You will then be reimbursed the previously approved amount.*
